Subject: Supplementing Public Housing Agency/Department of
Housing and Urban Development (PHA/HUD) Review and
Managerial Resources--Use of Outside Firms

1. Purpose. This Notice supercedes Notice PIH 94-75 (HA) by updating the list of contractors in Appendix 1.

The Department of Housing and Urban Development determined that a number of public housing agencies (PHAs) could benefit significantly from review or services contracts for analysis of problem areas, implementation of needed improvements, or management of one or more public housing developments by a private management firm. HUD placed an advertisement in the Commerce Business Daily on April 2, 1996, requesting firms interested in providing these services to PHAs, or to HUD, to submit their qualifications for Departmental review.

2. Use of Firms on List by PHAs. The contractors listed in this Notice are NOT HUD-approved consultants nor are they prequalified to provide services to PHAs. This list is not intended to be inclusive of all contractors that may be qualified. This list shall be used ONLY as a partial source list. It does not relieve a PHA from its responsibility to advertise and follow policy requirements and procurement regulations found at 24 CFR Part 85.36. PHAs must seek out and consider a wide range of sources in addition to those on the list. Interested firms not listed must be allowed to compete for contracts in any of the service areas covered by this Notice.

This list does not negate the required competitive process for selecting a contractor. PHAs are not to construe this Notice as authorization to enter into noncompetitive, sole source contracts with listed firms. All PHA contracts for technical and professional services are subject to the requirements of the Annual Contributions Contract, and the PHA's own procurement policy -- both of which are to be utilized in a manner consistent with the Federal regulatory procurement requirements found at 24 CFR Part 85.36. This Notice shall not be used as a basis for exception to any of these requirements.

HUD does not suggest that any of the firms in the Notice would necessarily be best able to address the particular needs of the PHA. PHAs shall check references, qualifications and other background information available on a firm, either listed in this Notice or otherwise, prior to entering into a contract for services. PHAs are expected to determine, pursuant to 24 CFR Part 85.36, if a contractor is responsible, based on its own records, the Government-Wide debarred and suspended list, the HUD Limited Denial of Participation (LDP) list, and any other information available to the PHA. Contracts will be executed between the PHA and the selected contractor. HUD is not a signatory to such contracts.

HUD also encourages PHAs to advise City-Wide Resident Boards and recognized resident leaders from the affected developments of the need for contracted services, and solicit their viewpoints on possible solutions to the problem(s) necessitating the services.

PHAs should work with the resident leaders to identify contracting opportunities wherein training/technical assistance could be provided to residents for initiatives such as drug-elimination, homeownership, resident management, economic opportunities for residents, and others. Likewise, HUD urges PHAs to include resident leaders in the process leading to the selection of firms, and in the evaluation of a contractor's recommendations for improvements in PHA operations prior to implementation. Resident groups should be considered, where opportunities exist, to assist in the implementation of a contractor's recommendations during and after the term of the contract.

The list of firms in this Notice may also be used by HUD as a potential source list should HUD decide to conduct its own procurement for management or review services for a PHA. Such procurement might occur in either of the following circumstances:

- a. HUD makes a declaration of substantial breach or default against a PHA. In such case, HUD would award the contract as the agent of the PHA and use the procurement procedures described in paragraph 4.
- b. If, in the absence of a breach declaration, HUD determines an unusual and compelling urgency exists that makes it necessary to award a contract directly (using the applicable statutory and regulatory requirements applicable to HUD

procurement) for needed services for a PHA.

In such cases, the procurement would be conducted by either HUD's Office of Procurement and Contracts at Headquarters or HUD's Administrative Service Center Contracting Divisions.

3. Evaluation of Contractor Qualifications. HUD evaluated the information each firm submitted based on the background and experience of the firms' principals and key staff and examples of specific work performed in the area(s) for which qualification was sought. References provided for work examples were also checked. Information reflective of a firm's past experience in successfully turning around troubled housing developments in the public, assisted or private sector, or in otherwise successfully addressing problems related to the management of rental housing, was given particularly favorable consideration in assessing the qualifications of contractors. Some of the firms listed in this Notice, while they appear to be qualified for a service area, were actually specialists within a sub-area. For this reason, it is recommended that PHAs contact listed firms to fully ascertain the specific range of expertise prior to requesting a firm to submit a proposal.

The Government-wide list of debarred, suspended and ineligible contractors and grantees was reviewed, as was the list of those contractors and firms subjected to a LDP by HUD, to ensure none of the firms listed in this Notice were on those lists. (Because a firm's status may change, PHAs must also check the list of debarred, suspended and ineligible contractors as well as check for LDPs and previous participation for any firms which may be selected for award, regardless of whether the firm is listed in Appendix 1.)

Qualifications of firms were sought for the following services. Appendix 1 lists those firms evaluated by HUD that appear to be qualified to provide the services listed thereon:

- (1) Management of large-scale real estate rental housing operations entailing administrative responsibility for all the service areas listed below.
- (2) Management of an individual, particularly troublesome, housing development(s) within a larger housing operation.
- (3) Review of all the basic operational components of

a large real estate operation, including services four (4) through 15, and ability to plan and implement needed improvements.

- (4) Ability to determine the physical and management causes of vacancies at a PHA and to make recommendations for correcting the problems causing such vacancies.
- (5) Review of security measures, and ability to plan and implement needed improvements.
- (6) Review of procurement policies, procedures and inventory control systems, and ability to plan and implement needed improvements.
- (7) Review of maintenance systems, including but not limited to daily maintenance procedures, maintenance staffing and organization, material and equipment access and utilization, preventive maintenance systems, etc., and ability to plan and implement needed improvements.
- (8) Review of automated data processing and management information systems, and ability to plan and implement needed improvements.
- (9) Review of budgeting and financial accounting and reporting procedures, as well as fiscal controls, and ability to plan and implement needed improvements.
- (10) Review of administrative staffing and organization, personnel management, personnel policies and procedures, including the effect of same on any State/local civil service requirements and/or implement needed improvements.
- (11) Review of labor union issues and past products of negotiations with unions, and ability to plan needed changes, as well as to assist in union negotiations.
- (12) Review of marketing and leasing management functions, including but not limited to resident selection, leasing of units, rent calculations and collection, annual reexaminations of family composition and income, transfers, marketing and outreach programs, evictions, etc., and ability to plan and implement needed improvements.

- (13) Review of utility system and potential for energy savings, including water conservation, and ability to plan and implement needed improvements.
- (14) Review of major building systems; i.e., plumbing, electrical, heating, cooling and structural, and ability to plan and implement needed improvements.
- (15) Review of the administration of major capital improvement programs, including cost estimating and knowledge of bidding and contracting procedures, and ability to plan and implement needed improvements.

- 4. Updated List of Firms. This list will be updated periodically to add additional firms as deemed appropriate.
